9. Meeting of the Trust Board.

The trustees of the board shall meet at least two times in a year. The present Chairman shall hold office for life or at his will. Subsequently Trustees may elect among themselves one Chairman. All resolutions adopted in the meeting of the Trust Board shall be recorded in the minutes book. All such meeting of the Trust Board shall be convened after giving due notice to all the trustees seven days before the meeting. In extraordinary situation where meeting can not be convened resolution may be passed by circulation and approved by required majority. In case of any dispute or equality in votes, Chairman of the meeting shall have a casting vote. Minutes of the proceeding of the meeting shall be signed by the Chairman of the meeting and shall be the conclusive evidence of any business transacted.

10 Power and function of the Secretary:

There shall be one Secretary to the Trust Board. He shall be the Chief Executive of the Trust. Secretary shall have following right, duties and powers while discharging his responsibility

- a. to look after the properties and assets of the trust with care and diligence and to keep all title deed or documents relating to the said properties.
- b. to enter into agreement and contract, to sue or be sued for and on behalf of the trust, subject to prior approval of the Trust Board.
- c. To keep proper account of the trust fund.
- d. To appoint, remove, terminate any employee or volunteer of the trust.
- e. To invest trust fund in approved investment scheme in the name of the Trust.
- f. To delegate any of his power to any other trustee, staff member, employee or any volunteer for any specific duty or purpose. Such delegation may be withdrawn at will.

12. Fund Management.

The Board of Trustee may from time to time open and maintain bank account in the name of the trust in such scheduled bank or other approved banks as may from time to time determined by the Trust Board and shall forthwith deposit or cause to be deposited all the surplus fund, profit, dividend and any other income accrue to the Trust Fund. Such bank account shall be operated by the secretary or any other person authorize by the Chairman of the Trust Board from time to time. All other receipts like grant , donations, endowments received by the Trust towards the trust fund or towards any specific purpose shall also be deposited in the bank account.

13. Accounts and Audit:

The Trust Board shall maintain regular accounts of the trust fund and project assistance and shall get the same duly audited by any qualified auditors as provided in the various provisions of Income Tax Act, 1961. The accounts and audit report shall be published annually along with the annual report of the trust.

14 Financial Year:

The financial year of the Trust will be from 1st April to 31st March . The accounts of the trust shall be closed on 31st March of every year.

15 Seal:

The Board shall provide a common seal and for its safe custody. The Seal shall not be affixed to any instrument except by the authority of a resolution of the Board of Trustee or a Committee of Trustees authorised by the Board in that behalf and except in the presence of at least two Trustees and of the secretary or such other person as the Board may appoint for the purpose; and those two Trustees and the Secretary or other person as aforesaid shall sign every instrument to which the Seal of the Trust is so affixed in their presence.

17. Indemnity.

Every Trustee and other officer or employee of the Trust shall be indemnified by the Trust against and it shall duty of the Trustee to indemnify them out of the assets of the Trust to pay, all costs, losses, damages and expenses which any such Trustee and other officer or employee may incur or become liable to be reason of any contract entered into or act or thing done by him as such Trustee and other officer or employee or in any way in the discharge of his duties including traveling expenses and in particular and so as not to limit the generality of the foregoing provisions against all liabilities, incurred by him as such Trustee and other officer or employee in defending any proceeding whether civil or criminal in which judgment is given in his favour or in which he is acquitted or in connection with any application in which relief is granted by the Court.

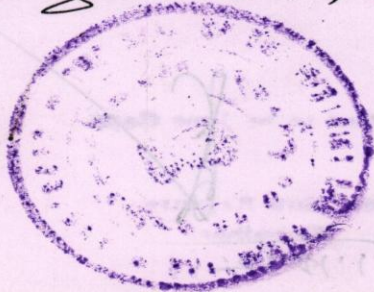
