





HOSTEL FEE FOR ACADEMIC SESSION 2022-23 (for the students availing the hostel facility)

- The Annual Hostel Fees of Rs 70,000/- (Rupees Seventy Thousand only) is **Non-Refundable** and is to be paid in **2-INSTALMENTS**, one at the time of admission and the 2nd at the end of 1st Term (the Exact date will be intimated later).
- 'Imprest Money' of Rs 5000/- (Rupees Five Thousand only) towards medical expenses and other exigencies.
